# Terms and Conditions relating to The Parlour at Kivells

---

## 1. Booking and Payment

Bookings can only be accepted from persons over 18 years of age and by paying the deposit, the client acknowledges that he or she agrees to the Terms and Conditions on behalf of the total party intending to occupy the property.

Reservations will be held as a provisional booking for 7 days or until a deposit of one-third of the cost is received. Cheques should be made payable to P&M Hosegood. Once the booking form and deposit are received, the balance is due 4 weeks before commencement of the holiday. No reminder will be sent and we reserve the right to cancel the booking if the balance is not paid by the due date. If a booking is made less than 4 weeks before arrival, the full cost is due at the time of booking.

## 2. Cancellation

All cancellations must be notified in writing. We will endeavour to re-let the property. If successful, all money paid will be refunded, less £30 expenses for re-letting. If we are unable to re-let the property, you are liable for the full balance outstanding. Cancellation insurance is strongly recommended.

## 3. Non-Availability of Property

If for any reason beyond our control, for example fire damage, the property is not available on the date booked, all monies will be refunded in full and we will not be liable for any further claims.

## 4. Arrival and Departure

The Parlour will be available for occupancy from 3 p.m. on the day of arrival and should be vacated by 10 a.m. on the last day.

## 5. Pets

One well-behaved pet is welcome. It must not be allowed on furniture and must be supervised at all times outside The Parlour. Under no circumstances should your pet be left unattended inside the property.

(Before deciding to bring your pet, you might bear in mind that between Easter and the end of September dogs are not permitted on many beaches in the area.)

## 6. Responsibilities

You are responsible for the property during your stay and it should be left in a clean and tidy condition at the end of your holiday. Any damage or breakages will be charged and must be reported to the owners prior to departure. No attempt should be made to repair or replace items.

The total number staying in the Parlour must not exceed 5 persons, excepting infants less than 2 years old.

No smoking is permitted in the Parlour at any time.

Please do not cause an annoyance or become a nuisance to other residents and visitors at Kivells.

The owners reserve the right to reasonable access of the property at any time for emergency maintenance etc.

## 7. Discrepancies

In the case of a discrepancy between these Terms and Conditions and any other information about The Parlour, these Terms and Conditions shall prevail.
